



## West Penn Wire—NSCA Technician Training and Certification Claim Form

### General Rebate From

Rebate dollar amounts up to 2% of material purchased from West Penn Wire will be issued and tracked by West Penn Wire. Please contact your West Penn representative to verify the rebate available to you, based on the amount of material purchased by your company. Rebates will come in the form of material credit.

Your rebate dollars may be accrued between January 1, 2009 and December 31, 2009. This amount may be applied toward NSCA EST Classes and exams completed between January 1, 2009 and December 31, 2009.

**Classes must be paid for and successfully completed by the registrant company by December 31, 2009.**

### Restrictions

EST Year 1, 2, 3 nine month programs must be completed prior to submittal. May and October 2008 completions will be eligible for submission. September 2008 starts will NOT be eligible for submission.

**Rebates earned between January 1, 2009 and December 31, 2009 may not be carried over to the following year.  
Rebates NOT claimed with the NSCA before December 31, 2009 will be considered null and void.**

### Obtaining a Rebate

After registering a candidate for one of the NSCA EST Programs listed on page 2 of this form, complete the requested information and fax to the NSCA at (319) 366-4164.

Claims will be reported to West Penn on a quarterly basis—but will be disbursed from West Penn on a yearly basis. The submittal of claim forms in conjunction with the completion of each EST event is encouraged in order to accommodate a timely disbursement at year end.

NSCA will verify participation and submit claims received to West Penn Wire on January 15, 2010. Rebates will be issued after January 15, 2010 by West Penn Wire. Please allow West Penn Wire 30 days to process claims and issue rebates.

*One rebate will be granted per person/per event between January 1, 2009 and December 31, 2009.*
